


Figure 1 Front view of cell (18500 1000mAh)




Figure 2 Top view of cell (18500 1000mAh)




Figure 4 Top view of cell (18500 1100mAh)




Figure 5 Front view of cell (18500 1200mAh)




Figure 6 Top view of cell (18500 1200mAh)




Figure 7 Front view of cell (18500 1300mAh)




Figure 8 Top view of cell (18500 1300mAh)

Figure 9 Front view of cell (18500 1400mAh)




Figure 10 Top view of cell (18500 1400mAh)




Figure 11 Front view of cell (18500 1500mAh)




Figure 12 Top view of cell (18500 1500mAh)




Figure 14 Top view of cell (18500 1600mAh)




Figure 16 Top view of cell (18500 1900mAh)
